### Terms and Conditions

- I acknowledge that wildlife hunting, fishing and travel have inherent risks including, but not limited to, hazards associated with possession of firearms and ammunition, travel by boat, plane, horseback and/or motorized vehicles, exposure to the elements and the presence of large animals, including bears and cougars, all of which may result in damage to my property and/or personal injury or death to myself. Accordingly, in consideration of Inzana Outfitters ("Inzana") accepting my application for guided wilderness hunting and/or fishing, I AGREE, FOR MYSELF AND MY HEIRS, EXECUTORS, ADMINISTRATORS AND ASSIGNS, AS FOLLOWS:
  - To assume any and all risks, dangers and hazards inherent with wildlife hunting, fishing and travel;
  - To WAIVE ANY AND ALL CLAIMS I may now and in the future have against, and RELEASE FROM ALL LIABILITY AND AGREE NOT TO SUE, Inzana and its servants, agents or employees for any personal injury, death, property damage or loss sustained by me as a result of my attending and/or participation in any guided hunting, fishing, hiking and/or sightseeing adventure offered by Inzana due to any cause whatsoever, including negligence on the part of Inzana, its servants, agents or employees;
  - TO SAVE, HOLD HARMLESS AND INDEMNIFY INZANA, its servants, agents or employees from any and all liability for property damage, personal injury or death suffered by myself or by a third party due to any cause whatsoever, including negligence on the part of Inzana, its servants, agents or employees.
- While participating in any guided hunting, fishing, hiking and/or sightseeing adventure offered by Inzana, I will at all times:
  - Respect and obey:
    - The laws of Canada and the Province of British Columbia;
    - The instructions of Inzana Guides, employees and personnel; and
  - Generally conduct myself in the manner expected of a responsible outdoorsman. Failure to do so may result in my immediate expulsion from the guiding adventure by Inzana, reporting to conservation and/or police authorities and forfeiture of my fees.
- I acknowledge that wildlife hunting and fishing is an unpredictable sporting adventure. As such, I understand that any itinerary, schedule and/or information provided by Inzana is a guideline only and not a contract. Factors such as weather conditions, seasonal variations in animal populations, mechanical breakdown, medical emergencies and/or acts if God may affect the success of my hunting/fishing adventure.
- I acknowledge that I am responsible for supplying all of my own firearms, ammunition, fishing rods and tackle, game bags, meat processing equipment, clothing, footwear, rain gear, sleeping bag, personal toiletries and gear, alcohol and tobacco.
- I agree that this Agreement will be governed by the laws of the province of British Columbia, Canada.
- I acknowledge that wounded game are considered harvested and will result in the cancellation of my species tag.
- I acknowledge that photos from my hunt may be used by Inzana for promotional purposes.
